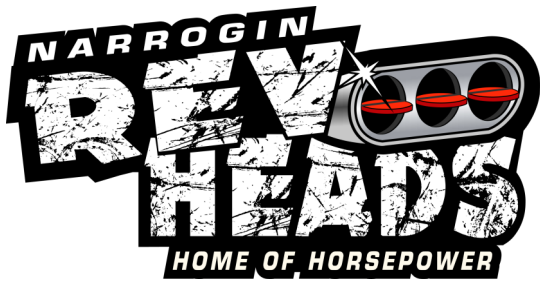

BURN 4 CASH COMPETITION T&C's

All competitors **MUST** register and pay before competing. Nomination fees are \$20 per driver. Payment details are listed on the Entry Form. **Weekend Gate fees are separate and must be paid upon arrival.

By nominating and paying entry fees you will be bound by the following rules of Narrogin RevHeads.

- 1) The burn-out competition will commence at approximately **5:00pm Friday 17th November 2017**
- 2) 24 Hours notice must be given if you are unable to attend. If failing to do so the \$20 entry fee will be forfeited.
- 3) No oil is to be used in the burn-out competition and burn-outs must be performed in an orderly and controlled manner. Any driver deemed not in control of the vehicle by officials will be immediately disqualified and ordered to stop.
- 4) Your time limit will start once you enter the water tray at the front of the burn-out pad and you will be given a maximum of **90 seconds** to complete your burn-out.
- 5) You may carry one passenger, you both must be wearing seatbelts and the appropriate attire must be worn (Helmets, closed in shoes, long sleeve shirt, long pants).
- 6) Maximum of two engine stalls will be allowed. After the second stall you will be asked to leave the pad.
- 7) After your time is up, a siren will sound and one of the officials will flash a light at you. You **MUST** leave the pad in a careful manner. If failing to do so, points will be deducted.
- 8) Any person found to be driving recklessly on in a dangerous manner from the pit to the burn-out pad will be automatically barred from competing in the days competition.
- 9) The car must be on the move at all times.
- 10) All wheel studs and nuts must be checked and tightened before any burn-out. No wheel weights permitted.
- 11) The judge's decision is final.
- 12) No liability is accepted for any damage to your vehicle.
- 13) As a competitor in this event, you owe duty of care to spectators and the public. On signing the Terms & Conditions, you have recognised and accepted that duty of care.
- 14) Your vehicle must be in good order. It is your responsibility to ensure your vehicle is in a safe condition. Officials have the right to disqualify your vehicle should it be deemed unsafe.
